nib holdings limited - Issue of Performance Rights

nib holdings limited (“nib”) has, on 8 April 2021 issued 12,861 Performance Rights to Dr Mellissa Naidoo (Group Executive Health and Chief Medical Officer) and 2,134 Performance Rights to Ms Roslyn Toms (Group Executive Legal and Chief Risk Officer) pursuant to nib’s Long Term Incentive Plan (“LTIP”) for the performance period commencing on 1 July 2020 and ending on 30 June 2024.

The Performance Rights have a nil exercise price and an expiry date of 1 September 2024. The Performance Rights are subject to vesting conditions based on Earnings Per Share growth targets and Total Shareholder Return conditions. The performance measurement period for the Performance Rights begins on 1 July 2020 and ends on 30 June 2024. If the Performance Rights vest and are exercised, eligible employees, will become entitled to receive one ordinary nib share (“Share”) for each Performance Right. A two year non-disposal period applies to 50% of the Shares allocated on the vesting and exercise of the Performance Rights.

Following this issue of Performance Rights nib will have the following unquoted securities on issue:

2,024,013 Performance Rights in total, comprising:

- 459,149 Performance Rights expiring 1 September 2021;
- 422,078 Performance Rights expiring 1 September 2022;
- 413,007 Performance Rights expiring 1 September 2023; and
- 729,779 Performance Rights expiring 1 September 2024.

The number of Shares on issue will not change as a result of the issuance of the Performance Rights and it is not expected that the number of Shares on issue will change if the Performance Rights are exercised. nib will inform the market of how many of the Performance Rights vest and are exercised and will confirm if Shares are bought on-market or issued to fulfil nib’s obligations under the Performance Rights. Currently, nib intends to fulfil its obligations by purchasing Shares on-market.
