

HealthCheck Privacy Collection Notice

Privacy and confidentiality

Honeysuckle Health Pty Ltd (ABN 55 637 339 694) ("Honeysuckle Health") provides health analytics services to nib Health Funds Ltd (ABN 83 000 124 381) ("nib").

nib is conducting the HealthCheck survey and will collect and store personal information from the member, share de-identified response data with Honeysuckle Health, and receive aggregated (de-identified) information from Honeysuckle Health as set out in this privacy collection notice.

This notice outlines how nib and Honeysuckle Health will collect and handle your data in compliance with the *Privacy Act 1988* (Cth) ("Privacy Act").

What you share

You will be asked to share personal information and health information, including:

- your height and weight;
- health behaviours (for example activity, diet, and smoking status);
- wellbeing; and
- health conditions.

Please note that all data you share in HealthCheck will be collected and stored, even if you don't complete all questions.

Your HealthCheck results will be available on your HealthCheck results page. If you log in to HealthCheck using your Health Insurance policy details and if the same email address is used for different members on the same policy, it will be possible to view all policyholder and dependent information, including HealthCheck results. Please review nib's **Online Terms** for more information.

How your personal information is used

nib will use your HealthCheck response data to provide you with personalised health insights, recommendations and to generate your HealthScore. The data will also be used to suggest products or services that may be relevant for you.

nib will securely share your de-identified data with Honeysuckle Health. Honeysuckle Health will not be able to identify you from the de-identified HealthCheck response data that they receive from nib. Honeysuckle Health will perform health analytics services on the de-identified HealthCheck response data which will be securely shared with nib on an aggregated level. nib will not be able to identify you from the aggregated information.

If you choose to complete the feedback form at the end of the survey, nib may use the anonymised response data to improve HealthCheck and user experience.

What we won't do with your personal information

Your participation or non-participation in the HealthCheck will not impact your nib membership in any way.

For private health insurance members this includes your premium and policy terms and conditions in line with community rating.

We will never use these health insights to:

- reject claims;
- change your premiums; and
- deny health cover.
