nib “Win the Ultimate Knights Match Day Experience” Competition

1. These Terms and Conditions apply to the nib “Win the Ultimate Knights Match Day Experience” competition (“**Competition**”). By participating, entrants agree to be bound by these Terms and Conditions.
2. Entries must comply with these Terms and Conditions to be valid.
3. The Promoter is nib health funds limited ABN 83 000 124 38 of 22 Honeysuckle Drive, Newcastle NSW 2300. (“**Promoter**” or “**nib**”).
4. This Competition is a game of chance.
5. The Competition commences at 9:00 am AEST on Wednesday, 10 June 2026 and closes at 11:59 pm AEST on Sunday, 28 June 2026 (“**Competition Period**”).
6. Six (6) x individual prizes are to be won (1 x major prize, 5 x minor prizes). The major prize consists of one (1) x 2026 Newcastle Knights signed home jersey; two (2) x Western Corporate Hospitality suite tickets to the Newcastle Knights v Dolphins NRL match on Sunday, 5 July 2026 at McDonald Jones Stadium; the opportunity for the major prize competition winner (“**Major Prize Winner**”) to take part in the pre-match Coin Toss at the game and a ‘meet & greet’ with Paul “Chief” Harragon (“**Major Prize**”). The coin toss and meet & greet are ‘money can’t buy’ experiences with no retail or monetary value and are not included in the total prize pool. Each of the five (5) minor prizes consist of two (2) x Adult Eastern Grandstand seat tickets to Newcastle Knights v Dolphins NRL match on Sunday, 5 July 2026. (“**Minor Prize**”). How to enter

7. Entry into the Competition is only open to members, who at the time of entry and at the time of the Prize draw:
 - a. are aged 18 years or older on the date on which they enter the Competition;
 - b. hold an Extras, Hospital, Ambulance, or Overseas Cover with nib; and
 - c. are up to date with any premium payments if applicable (“**Eligible Entrants**”).
8. To be eligible to win, Eligible Entrants must complete the following steps during the Competition Period:
 - a. go to Rewards by logging into the nib App or nib Member Account online. To access Rewards:
 - i. all members must accept the Rewards terms and conditions (if they haven’t already done so).
 - ii. nib members with private health insurance must have a policy start date more than 30 days in the past.
 - b. Go to the Competitions entry page within the Rewards platform, complete all required entry fields and submit their Competition entry.
 - c. Be an active member of nib at the time of the Prize Draw on Monday, 29 June 2026 (excludes members whose policy is suspended, in arrears or on hold); and
 - d. Have a first name, last name and valid email address registered on their nib membership or policy to be notified by the Promoter if they

Eligible Entrants must not be an employee of the Newcastle Knights, the National Rugby League (NRL), the Promoter, or its related entities and must not have any immediate family members who are employees of the Newcastle Knights, the NRL or the Promoter or its related entities. Immediate family means spouse, de facto spouse, child or stepchild (whether natural or by adoption), parent or step parent, grandparent, uncle, aunt, niece, nephew, brother, sister, step brother or step sister or first cousin.
10. Eligible Entrants can enter only once.
11. Entries must be received during the Competition Period and will be deemed to be received only when they have actually been received by the Promoter.

 - d. do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this Competition;
 - e. breach any law or infringe any third-party rights including intellectual property rights; or
 - f. use any other mechanical or electronic means that allows the individual to automatically enter repeatedly.
39. The Promoter is not liable for entries, Prize claims or correspondence that are misplaced, misdirected, delayed, lost, incomplete, illegible or incorrectly submitted.
40. If any dispute arises between you and the Promoter concerning the conduct of this promotion or claiming a prize, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. Nothing in these Terms and Conditions limits, excludes, modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia.
49. Personal information is being collected by the Promoter for the purpose of conducting and promoting this Competition, and to assist the Promoter to improve its services. By entering this Competition, an entrant consents to storage and use of their personal information by the Promoter in accordance with its [Privacy Policy](#).
