NDIS funding.

A guide to Core, Capacity Building and Capital Support Budgets.

The first thing to know about NDIS funding is that it can be allocated to three different types of budgets: Core, Capacity Building and Capital Supports.

Each type of budget is linked to specific outcome domains. These outcome domains align closely with the goals of a participant's NDIS Plan (e.g., social and community participation, health and wellbeing, or support with daily living). Funding allocated to each budget can then be used to purchase supports from designated categories.



Core Budget

The most flexible budget. Can be used for a range of supports that assist participants with daily living tasks. While flexible, it cannot be used for capital or capacity building supports.

Capital Support Budget

Funding can be allocated when a participant requires investments, such as assistive technologies to support their goals. An example of this could be vehicle modifications, equipment, or Specialist Disability Accommodation (SDA). The funding in this budget can only be used for specific items that are listed in the participant's plan.



Capacity Building Budget

Matched to the goals in a participant's plan, Capacity Building Budget can be used for supports to build skills and independence.

Providers must clearly inform participants if they have any conflicts of interest, including if they might benefit from recommending certain services. They also have to manage these situations in a fair and open way.

This is designed to protect participants' choice and make sure advice and support is in their best interest.

Daily personal activities.

A flexible service that can include practical help or supervision from a support worker for a wide range of personal tasks in daily life (e.g., bathing, dressing, toileting).

Assistance to access community, social and recreational activities.

Supports to help participants engage in community based social and recreational activities. May take place at a centre or in the community.

Assistance with household tasks.

These services are used to support participants to maintain their home environment. These tasks can't be done by a participant and can include things like general house and yard maintenance or house cleaning support.

Support coordination.

Support coordinators have become central to the functioning of the NDIS. They help participants design goal-oriented, consumer-focused plans of support. Support coordinators also help to link participants to non-NDIS services where appropriate.

Support coordination is split into three levels, depending on the complexity of a participant's needs.

Transport.

If a participant can't use public transport without significant difficulty due to their disability, they may be able to access transport as part of the delivery of certain supports, or as dedicated transport funding.

Activity Based Transport.

If you're receiving supports through your Core or Capacity Building Budget, you can request your service provider to transport you to the activity you're doing as part of your supports. This is called Activity Based Transport.

Please note:

Activity Based Transport is not subject to price limits. It's charged at a "notional" unit limit of \$1.00, up to the amount agreed between provider and participant.

Example:

Claiming for Activity Based Transport.

The Activity Based Transport support items are not subject to price limits but have a 'notional' unit limit of \$1.00.

As an example, a participant and provider agree that the non-labour costs of Activity Based Transport (support item 04_590_0125_6_1) should be \$21.50. The provider would submit a payment request for 21.5 units at \$1.00 a unit for a total cost of \$21.50.
