

Priceline “Up To 48,000 Sister Club Points” Offer

Terms and Conditions

1. These Terms and Conditions apply to the Priceline “Up To 48,000 Sister Club Points” Offer (“**Offer**”). This Offer and these Terms and Conditions are issued by nib health funds limited ABN 83 000 124 381 (“**nib**”). By participating, claimants agree to be bound by these conditions. Claims must comply with these conditions to be valid.
2. The Promoter is Priceline Pty Ltd ABN 18 005 968 310 of 250 Camberwell Road, Camberwell, Victoria 3124, Australia (“**Promoter**” or “**Priceline**”).
3. The Offer commences at 12:00 am (AEST) on 15 April 2021 and closes at 11.59pm (AEST) on 30 May 2021 (“**Offer Period**”).
4. The Offer is open only to permanent residents of Australia who are 18 years or over as at the date of joining (being the date of completion of join) (“**Eligible Members**”).
5. The Offer is only available to members who join an nib **combined Hospital and Extras Australian resident’s health insurance product** (“**nib ARHI product**”) through nib’s website www.nib.com.au, or through nib’s Contact Centre during the Offer Period (“**Eligible Product**”), and does not apply to a purchase of an nib Overseas Students Health Insurance, nib International Workers Health Insurance, nib Corporate Private Health insurance, Qantas Health Insurance, Suncorp Health Insurance, GU Health Insurance, AAMI Health Insurance or Apia Health Insurance policies, or those moving from one of these products to an nib ARHI product. The Offer excludes any non-health related insurance products (e.g. Travel) and dependants moving from family/parent’s health cover to their own policy.
6. For clarity, Eligible Members who join an Eligible Product (during the Offer Period), which has a policy start date outside of the Offer Period, can qualify for the Offer subject to their compliance with:

- a) these Terms and Conditions (including, but not limited to, the Eligibility Requirements); and
- b) any other terms and conditions imposed by nib in relation to the selection of policy start dates.

7. The Offer consists of up to 48,000 Priceline Sister Club Points Valued at \$600 (inclusive of GST). 48,000 is the maximum number of sign on Priceline Sister Club Points that can be earned upon purchase of an **Eligible Product** with an annual premium above or equal to \$6,000. The number of Priceline Sister Club Points awarded will vary based on the total premium of the health insurance policy. For detail on the number of points awarded, please see the table below noting that “Annual Premium” refers to the total annual cost of the policy exclusive of any Lifetime Health Cover Loading, Age Based Discounts or Government Rebates.

8. Eligible Members must meet all of the following entry requirements (“**Entry Requirements**”):
 - a) the Eligible Member must successfully join and commence an Eligible Product during the Offer Period through nib’s website www.nib.com.au, or through nib’s Contact Centre;
 - b) the Eligible Member must maintain the Eligible Product up to the date of the Offer being applied to the active policy, being:
 - i. **14 July 2021** for Eligible Products purchased between 15 April 2021 and 30 April 2021; and

- ii. **12 August 2021** for Eligible Products purchased between 1 May 2021 and 30 May 2021, each a "**Fulfilment Date**".
 - c) The Offer will be forfeited if the Eligible Members is not an active policyholder on their Fulfilment Date.
 - d) the Eligible Member must not be a current policyholder of a product issued by nib (including Qantas Health Insurance, Suncorp Health Insurance, GU Health Insurance, AAMI Health Insurance, Apia Health Insurance, nib International Workers Health Insurance, nib Overseas Students Health Insurance or nib Corporate Health Insurance) at the time of joining the Eligible Product, or have joined and cancelled an Eligible Product 6 months before or during the Offer Period;
 - e) the Eligible Member must have a valid email address applied to their Eligible Product;
 - f) the Eligible Member must not be an employee of the Promoter; and
 - g) the Eligible Member must be a current Sister Club member.
9. Limit of one Offer per policy for each Eligible Product joined during the Offer Period.
10. The Offer cannot be combined with any other offer or promotion.
11. If an Eligible Member has satisfied the Entry Requirements, the Promoter will award the Sister Club Points to the Eligible Member's Sister Club account on the Fulfilment Date. This transaction will appear in the Eligible Member's online Sister Club account as part of their transaction history.
12. Each Eligible Member acknowledges that:
- a) the Sister Club Points will be applied to the Eligible Member's account, by the relevant Fulfilment Date.
 - b) the Sister Club Points awarded under this Offer are earned through Priceline Sister Club Partner Perks.
 - c) to earn the Sister Club Points under this Offer, they must enter the unique promotional code provided.
 - d) the Sister Club Points awarded under this Offer contribute to the Eligible Member's quarterly reward value and not to the member's Sister Club tier status.
- e) points that have been obtained by or through fraud or other illegal activity are deemed invalid.
 - f) Priceline's Sister Club Points, and the use of those Points to make purchases at Priceline, are subject to Priceline's policies and terms and conditions, which are available at: <https://www.priceline.com.au/priceline-policies>.
13. Except for any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law), nib and the Promoter exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way in connection with this Offer, including but not limited to:
- a) any technical difficulties or equipment malfunction (whether or not under nib's or the Promoter's control);
 - b) any theft, unauthorised access or third-party interference;
 - c) any tax liability incurred by an Eligible Member (independent financial advice should be sought); or
 - d) accepting the Offer and/or using the Sister Club Points.
14. Nothing in these Terms and Conditions restricts, excludes, modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010* (Cth).
15. nib and the Promoter reserve the right to withdraw or substitute any part of this Offer with another offer of equal or greater value at nib's or the Promoter's sole discretion. Eligible Members will not be entitled to any additional compensation in the event that the Offer or element of the Offer has been substituted at equal or greater value.
16. nib and the Promoter are not responsible for any undelivered emails due to an Eligible Member's spam filters or email settings.
